The Lecturer Team Successfully Acquired HK\$30,000 for the "Student as Partners" (SaP) Funding Scheme Launched by the General Education Office

The Department is thrilled to announce that the History Lecturer Team has won the "Student as Partners" (SaP) Funding Scheme and will be given HK\$30,000 to conduct its pilot project on two courses: GFHC1045 Hong Kong between Past and Present (Dr. Fong-fong Chen) and GFHC1055 Global China in the Modern Age (Dr. Kam-chau Kwok).

The "Student as Partners" (SaP) Funding Scheme launched by the General Education Office (GEO) which targets to provide students with work opportunities in learning and teaching of GE courses, is now available for application. Each level 1 or level 2 GE course can apply for an one-off amount up to HK\$30,000 to develop its own SaP where course instructors are encouraged to provide paid work opportunities for their students, such as tutoring, community service, website design and conduct of fieldtrips.

In the late afternoon on 8 January, Dr. Kam-chau Kwok and Dr. Fong-fong Chen attended a session of the MATCH meetings with NGOs such as the Okapi Studio, Aka Lin Heung and Aroma Office organized by GEO. It is a social enterprise set up by HKBU alumni Max Cheng and Johnny Lo to promote social inclusion. Members learnt about possible collaboration opportunities.





一年級新生獲歷史系提名,成功奪取「中銀香港中史優異生獎學金」 Freshman Nominated by the Department of History Awarded Bank of China (Hong Kong) Scholarship for Outstanding Student in Chinese History (2019.12.9)



Nominated by the Department of History, a Year one broad-based student Ying-hong So from the Faculty of Social Sciences (SOSC) was awarded the Bank of China (Hong Kong) Scholarship for Outstanding Student in Chinese History, basing on her outstanding DSE result in Chinse History. Ying-hong was invited to attend the award presentation ceremony which took place at the Endeavour Education Centre Limited on 9 December 2019, as one of the ten awardees in local universities.

Offered and donated by the Endeavour Education Centre Limited and the Bank of China (Hong Kong) Limited respectively, the Scholarship seeks to encourage more students to take Chinese History in secondary school and to stimulate their interest in studying Chinese History. Freshmen who obtained 5** in DSE Chinese History are eligible to be nominated by their universities/ departments or to apply on their own. Each awardee will receive a total amount of HK\$50,000.

The History Department has consecutively nominated freshmen to fill the awards for four years. Past awardees include Hok-chung Yip (now a Year 4 History student), Wan-yi Li (now a Year 3 History student) and Ho-wai Tsui (now a Year 2 student).

「中銀香港中史優異生獎學金」由勵進教育中心籌劃,並得到中國銀行(香港)贊助,目的是鼓勵更多同學選修歷史科,從中提升學生對中國歷史的興趣。另外,透過該獎學金鼓勵更多中史科成績優異的同學選擇入讀本地大學歷史系,加深香港青少年對中國的了解和認識。凡設有歷史系的本地大學,可提名一位於中學文憑試中史科成績達5**的新生,未獲校方提名者亦可自行申請,競逐餘額。每位得獎學生將獲得港幣五萬元的獎學金。

今次是歷史系連續四年提名一年級新生獲獎,上幾屆得獎學生分別是葉學錝同學(現為歷史系四年級學生)、李韵怡同學(現為歷史系三年級學生)及徐浩威同學(現為歷史系二年級學生)。





Introduction:



Dr. Fong-fong CHEN 陳芳芳博士



A famous quote from the timeless book *The Little Prince* by Antoine de Saint-Exupéry reads, "It is only with the heart that one can see rightly; what is essential is invisible to the eye." While looking is a crucial act for seeing and understanding the relationships between things and ourselves, the author reminds us that we should see not just with the eyes; seeing and understanding what truly matters in life also requires our minds and emotions. The Little Prince was able to perceive that the picture did not depict a hat; it represented a boa constrictor swallowing an elephant. Art is a medium for communicating ideas, thoughts, and emotions, and even documenting history. I am profoundly intrigued by everyday images, their interplay with words, and how each separately or collaboratively play a role in the understanding of the present and the past. My interest in the history of art was inspired by my desire to use ready-made objects to make works of art and play with art forms in relation to the space. As a result of this interest in the links between materials and everyday experiences, I created experiential installation works for local exhibitions and sets for theatre productions in my younger days.

As a historian and curator of Chinese art and visual culture, my research focuses on representations of women and women's fashions in different visual media in China from the eighteenth to the twentieth centuries. I am also interested in print studies, the history of photography, and the art and history of Hong Kong and modern China. Prior to joining the Department of History (HKBU), I taught at various local universities, including the University of Hong Kong (HKU), the HKU Space, the Hong Kong University of Science and Technology, Lingnan University, and the City University of Hong Kong. My hands-on curatorial and museum practice have informed my research into museum studies. I was an associate curator at the University Museum and Art Gallery at HKU and a J.S. Lee Memorial Fellow (2013/2014) and a visiting scholar at the UC Berkeley Art Museum and Pacific Film Archive (BAMPFA).

突然得知要寫Newsletter,感到有點不知如何,也不知道應寫什麼。我在想,歷史系的系訊,雖然說主題無所謂,但又無理由當作日記般寫無聊事情,不過剛剛去了日本一趟,那麼便寫在日本的經歷。

我去日本主要是遊歷大阪、京都附近的舊城。事實上,旅遊本來就應周圍走走,看看當地才見到的東西,而不只是購物。(應該並非本人貧窮,無錢,才說的。)

首先聲明,本人並非日本城池的專家,有錯歡迎指正。我遊歷了不同的城池,但是日本很多天守閣其實都不是真跡,有的更沒有原圖,要參考不同資料以及同期天守重建。





以我的金魚記憶,我記得左圖是彦根城,右邊則是長濱城。事實上,彦根城才是真正的木製天守閣,其他城池則像長濱城一樣,很多是戰後重建的,當然,不一定是戰爭之中被戰火摧毀,有的是閃電擊中起火焚毀。日本有一百座名城,但大多都是重建的,例如大阪城,以及有名的姬路城也是局部重建的。

登上彦根城,又是另一個故事。彦根城的樓梯很斜,雖然我數學不好,但一眼也可以看出,那樓梯的角度絕對大於45度。基本上我是用爬山的方式登頂。當然,登頂後看到琵琶湖的景色則值回票價。(其實長濱城有電梯去到三樓,走兩層易走的樓梯,可以一覽更美的琵琶湖景,但要安慰一下爬了五層山的自己,有必要強說是值得。)

Sharing by Old Friends & Alumni 老朋友和校友的分享

Mr. Kwok-fai LAW 羅國暉先生

BA (Hons) in History, 2012 PhD Candidate, History department, SOAS, University of London



It's a great pleasure for me to be invited by Miss Michelle Chan to share my recent news about the passing of my PhD viva voce examination at the School of Oriental and African Studies [SOAS], University of London. I was once an undergraduate who spent four years studying in the HKBU history department. After graduating from HKBU, I was awarded an MPhil degree from Lingnan University where I examined the periodisation of Britain's inter-war imperial decline in East Asia and the awakening of legal consciousness amongst ordinary Chinese, as reflected in the Shanghai Municipal Police's arrest of Communists between 1927 and 1937. Following the completion of my study at Lingnan, I was very fortunate to receive the Swire Scholarship in Chinese History, which has fully funded my doctoral research at SOAS. Supervised by Dr. Lars Laamann, my research, which is closely linked with the history of China's treaty ports, sheds light on the solidarity among a group of adult passenger attendants called Chafang 茶房 'teaboys' in the Chinese shipping industry during the Republican period. Utilising English, Chinese, and French archival materials, my thesis makes a new contribution to Chinese labour history by stressing that the teaboys' class relationship originated from a sense of political pragmatism and the pursuit of economic betterment, instead of being merely rooted in cultures, traditions and ideas.

Sharing by Old Friends & Alumni 老朋友和校友的分享

Last month, I passed my viva voce examination chaired by Prof. Robert Bickers and Dr. Chung-yam Ronald Po 布琮任 – coincidentally also a graduate of the HKBU history department – with minor corrections only. My two examiners, who were largely satisfied with my thesis, were very kind to give me a lot of useful, incisive comments which facilitated the removal of a number of errors from my thesis and helped me bridge my research to a wider scope of Chinese history. While waiting for my examiners' official reports, I have started applying for jobs available in different academic institutions. It is my hope that I can keep taking part in the academic exchange on Chinese social-political history and Sino-Western exchange by publishing my current research findings, and by starting a new postdoctoral project on the twentieth-century scout movement in Republican China.

I would like to take this opportunity to express my deepest gratitude to the faculty members of the HKBU history department for their steadfast, comprehensive support provided to me. Thanks go to Prof. Wing-chung Clara Ho 劉詠聰 for suggesting an array of secondary literature relating to my current research projects, to Dr. Bettina Dietz, for supervising my honours project for my bachelor's degree, to Dr. Catherine Ladds, for offering many valuable comments on my MPhil thesis in her capacity as my external examiner, and to many departmental staff who cultivated the knowledge and skills I have needed in the pursuit of my research on modern Chinese history. Without the foundational training I received at the HKBU History Department, I would not have been able to further pursue my study in the United Kingdom. May I wish all faculty members and students at the history department a productive, fruitful year ahead!
